The families that have signed the SRS participation agreement form in previous years will be automatically invoiced, unless they choose to opt out with a new SRS form completed and returned to the CSS finance office. Further information regarding the SRS is outlined below.				

Parents are directly responsible for providing textbooks and other personal resources such as pencils, exercise books and other items for their child's individual use while attending school. Toward the later part of the year, CSS will provide details of the items required for use in class and the supplier that can be used to purchase the book pack economically. Additional to the book pack **Coombah State School** has chosen to operate a Student Resource Scheme (the "scheme"/ "SRS") for 2026, at a cost of \$70.00 per student which provides other student resources and consumables such as online learning program access, art and craft materials, project materials, ingredients for science experiments, cooking and other items listed below.

The scheme operates under the policy and guidelines of the Department of Education (DoE) and is approved annually by the P&C Association.

BENEFITS OF THE SRS SCHEME

- Saves parents/carers time and provides value for money. Appropriate textbooks, e-learning resources and other materials are supplied under the scheme.
- Students have the required resources to enhance their classroom learning.
- The school can secure savings through bulk purchases and discounts which are passed on to families through the scheme.

Participation in the Student Resource Scheme also ensures that teachers can distribute resources to students immediately, thus improving the quality of teaching and learning time for all.		YOU PAY \$70.00

Parent/s choosing not to participate in the SRS will be provided with a list of resources that you will be required to purchase to ensure your child/children can participate fully in curriculum & other classroom activities throughout the school year. A parent's decision to participate is based on consideration of the value afforded by the scheme. If a parent chooses to participate in the scheme and completes the Participation Agreement Form, a fee will be due and payable. **It is important to note that the SRS is only offered as a complete package.**

For new students enrolling during the school year, payment is required upon enrolment and parents will be charged a pro rata participation fee for a student who enrolls after the first week of school, calculated on a 40- week school year basis.

All items provided for temporary student use by the SRS remain the property of the school and shall be returned at the end of the education program, school year or when the student leaves, whichever is earlier. Items provided for temporary student use must be kept in good condition by the student. Where an issued item is lost, negligently damaged or not returned, the parent may be liable.

THE STUDENT RESOURCE SCHEME DOES NOT INCLUDE:

- Financial contributions to supplement the instruction, administration and facilities for the education of the student at school.
- Resources funded by the state through grant funding to provide a core educational service including student internet access during class time.
- Schools' optional activities such as the costs for excursions, swimming, instrumental music, camps, performances and graduation.

NOTE: Before a student can be considered for participation in an optional school activity, excursion or camp, a parent is expected to have:

- ✓ Fully paid all outstanding fees or
- ✓ Paid the SRS and other outstanding fees up to and including the week in which the activity takes place or
- ✓ Made regular on-going payments towards these fees, as previously arranged with the Finance Officer or Business Manager or
- ✓ Been exempted by the Principal from paying all or part of these fees.

A student, whose parent has joined the Student Resource Scheme but not paid the participation fee, will continue to be provided with instruction, administration and facilities for their education, however the student will not receive passwords for on line learning and SRS resources. These will be provided when payment has been made or an agreed payment plan is in place.

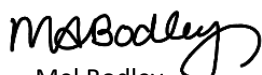
The schools' policy endorsed by the P&C is that prior to any excursions, camps, senior jerseys, swimming program, instrumental music program, YR4 SAKG, school camps etc, all SRS and extra-curricular payments should be finalised, or if on an agreed payment plan - payments are up to date. Exceptions will be by negotiation with the Business Manager only.

PARENTS EXPERIENCING FINANCIAL DIFFICULTIES

A parent wishing to participate in the Student Resource Scheme and experiencing financial hardship is encouraged to contact the Finance Officer or Business Manager to discuss how their financial obligations can be met throughout the school year, or to negotiate an alternative arrangement that may be available to accommodate their individual circumstances. Onus of proof of being so affected is on the parent. A negotiated payment plan will need to be completed by the parent, with payment in full by the end of May 2026.

REFUNDS

The school may make a pro rata refund to the parent of a student who, having paid the SRS fee, completed a refund form and has left the school during the year. The pro rata refund is calculated on the fees paid, less the cost of consumed materials and the replacement cost of scheme items that are lost, negligently damaged or not returned. (eg: instrument, library books)
